

## TERMS AND CONDITIONS FOR THE BREWIN DOLPHIN £250 GARDEN VOUCHER PRIZE DRAW

5. All entries received after the Closing Date are automatically disqualified. In addition, any incomplete entries will also automatically be disqualified.

We will also not be able to accept proof of posting or transmission as proof of receipt of entry to the prize draw.

If there is any reason to believe that there has been a breach of these terms and conditions, we may, at our sole discretion, reserve the right to exclude you from participating in the prize draw.
